PLIPDECO hereby invites tenders from licensed dealers in old metal or marine stores for the PURCHASE AND REMOVAL of SCRAP IRON AND STEEL PRODUCTS (hereinafter referred to as "Scrap Items") from PLIPDECO's Port Compound:

All persons entering the Port are mandated to attire themselves with the proper safety shoes, hard hat and reflective vests.

TENDER SUBMISSION REQUIREMENTS:

1. This Tender is open to all, local contractors, firms, companies and joint ventures registered or incorporated in/or having a place of business in Trinidad and Tobago, provided that they are licensed dealers in old metal or marine stores under the *Old Metal and Marine Stores Act, Chapter 84:07*.
2. Tender documents are available for a non-refundable tender fee of Three Hundred Dollars (TT\$300.00) payable by certified cheque to **Point Lisas Industrial Port Development Corporation Limited**. Persons who paid and collected tender documents before in response to our previous Tender Notice shall produce their receipt in order to collect their revised tender documents.
3. Tender documents **SHALL** be available to be collected **Thursday August 17th, 2017, to Friday August 18th, 2017 between the hours of 8:30 a.m. to 3:00 p.m.** from the Corporate Secretariat Department, PLIPDECO House, Orinoco Drive, Point Lisas Industrial Estate, Couva.
4. **Tenderers shall submit bids for a minimum of 100 tonnes of Scrap items.**
5. Tenders **must** be accompanied by the tenderer's Licence, Certificate of Incorporation or Continuance, a valid V.A.T. Clearance Certificate, Last Annual Return filed with the Companies Registry, and Income Tax Clearance Certificate issued by the Board of Inland Revenue and dated not more than six (6) months prior to the Tender Closing Date and a copy of the Tender Document Receipt.
