



## NOTICE 11 – 2019: REVISION TO TARIFF STRUCTURE – ADDENDUM

May 10<sup>th</sup>, 2019

Further to our Notice No. 30 - 2018, please be advised of an Addendum to **Items 2.8, 3.10, 3.14, 3.18, and 4.1.2** as well as the inclusion of an additional **Item 8.0 - charges for Security Services** as listed below:

### Tariff Item 2.8.1 and 3.14.1- LABOUR STANDBY

- Standby charges will not be applicable based on the vessel's late arrival and berthing alongside. A grace period of two (2) hours for accrual of standby charges will be applicable from commencement of the respective shifts (0700/1500, 1500/2300 and 2300/0700). Thereafter standby charges will be applicable as per Tariff.

### Tariff Item 3.10.2 – HEAVY LIFT - DIRECT DELIVERY

- Applicable as follows – Shore crane: 40 MT to 60 MT

### Tariff Item 3.18 - STORAGE RENT AT TERMINAL – BREAKBULK

- Export cargo will receive Fourteen (14) FREE Calendar Days.

### Tariff Item 4.1.2 – HATCH COVERS – Using drop wires and gears

- Applicable to container vessels only

### Tariff Item 8.0 - SECURITY SERVICES (New Charges)

- 8.1 Gate Passes
- 8.2 Load Escort (Wide)
- 8.3 Providing Security Services for IMO Class 1 Containers on Port
- 8.4 Securing of Vessel Gangway
- 8.5 Unauthorised Parking - Clamping

Please note that the above adjustments and charges for will become **effective May 20<sup>th</sup>, 2019**.
