



NOTICE 04-2020: REVISION TO TARIFF STRUCTURE

January 24th, 2020

Please find attached PLIPDECO's revised Tariff Structure which will take effect **February 1st, 2020**. Note that there are no increases to existing line items at this time.

The main changes to the Tariff are the addition of new line items, as well as the insertion of notes for existing items to provide further clarification. The new items are identified by asterisks (*) in the Tariff and are outlined below:

Section 1.4 - SPECIALIZED TERMINALS (Adjustment to description/rate/notes)

- 1.4.1. Vessel under 15,000 GRT will be US\$450.00 per move
- 1.4.2. Vessel above 15,000 GRT will be US\$0.03 GRT per move

Section 1.6 - BUNKERING (New Charge)

- 1.6.1. Throughput charge for fuel via Tank wagon will be US\$500.00 per tank wagon.
- 1.6.2. Throughput charge for fuel via Ex-barge will be US\$3,000.00 per vessel.

Section 2.10 – STORAGE RENT AT TERMINAL – FULL: DANGEROUS CARGO/TANKTAINER/CONTAINER (New Charge)

- 2.10.3. Fireworks, arms, ammunition, explosives and any other class of dangerous cargo will be US\$250.00 per container per day.

Section 2.15 – HEAVYLIFT CONTAINER/FLATRACK – 40MT and above (New Charge)

- 2.15.1. Discharge will be US\$5,500.00 per container.
- 2.15.2. Load will be US\$5,500.00 per container.

Section 4.10 – STOWAGE INFORMATION (New Charge)

- 4.10.2. Manual creation (building) of vessel plan in Terminal Operating System will be US\$200.00 per vessel.

Section 4.24 – SPECIALIZED HANDLING (New Charge)

- 4.24.1. Cargo requiring specialized handling will be US\$2,700.00 per 8 hour shift.

- 4.25.1. Daily Rate or part thereof for the temporary parking of container/chassis will be US\$8.00 per container.

Section 8.3 – SECURITY PROVISION – CLASS 1 IMO DANGEROUS CARGO CONTAINERS (Adjustment to rate)

- 8.3.1. Providing Security Services for IMO Class 1 Dangerous Cargo Containers on Part:
Weekdays US\$15.00 per hour | Weekends US\$30.00 per hour | Public Holidays US\$45.00 per hour
