

NOTICE 04 – 2021: CLAMPING OF ILLEGALLY PARKED VEHICLES ON THE INDUSTRIAL ESTATE

January 27th, 2021

In order to curb the prevalence of illegally parked vehicles and ensure the safety of all users of the Industrial Estate, PLIPDECO will continue with the clamping of all vehicles illegally parked along the roadways and on unauthorised vacant parcels of land throughout the Industrial Estate.

Signs have been erected at all entrances to the Industrial Estate as well as at other locations advising of this procedure. These signs state that the Industrial Estate is a No Parking Zone and that vehicles illegally parked will be clamped or towed away at the owners' expense and shall be returned upon the payment of a fee.

It should be noted that:

- Illegally parked vehicles will be identified by our Security personnel during their mobile patrols.
- Clamps will be placed on the wheels of said vehicles, rendering the vehicle immobile.
- Owners will be required to pay the fee at the Port before the vehicle is released.
- A Security Officer will then accompany the owner to the site of the vehicle where the clamps will be released.
- The charge shall be Two Hundred Dollars (TT\$200.00) or Five Hundred Dollars (TT\$500.00) depending on the class of vehicle as per the schedules below:

Schedule 1 - \$200.00 fine:

- Motorcycles;
- Wheel tractors;
- Light motor vehicles (including private motor cars, taxis with a tare weight not exceeding 2270 kilogrammes, maxi-taxis whatever their tare weight and light goods vehicles not exceeding a maximum gross weight of 2950 kilograms).

Schedule 2 - TT\$500.00 fine:

- Heavy motor vehicles (including motor vehicles whose maximum gross weight exceeds 2950 kilogrammes but does not exceed 15240 kilogrammes);
- Extra heavy motor vehicles (including motor vehicles whose maximum gross weight exceeds 15000 kilogrammes);
- Motor omnibuses
- Any other Motor Vehicles not identified in the above schedules shall be fined at the Officer's discretion.
